Please note that SC/ST/Cat-1/2A/2A/3A/3B eligibility criteria are applicable to SC/ST/OBC Karnataka candidates only.

Candidature is purely provisional and subject to fulfilment of eligibility criteria as mentioned in the AIAPGET-2019 Information Bulletin, further the provisional admission made is subject to approval of CCIM / CCH / Government / Competent Authority / Universities etc. Mere registration or verification the documents does not confer any right to the candidates for admission to Karnataka AYUSH PG MD / MS courses.
