NOTIFICATION

Sub:- Publication of intake of Seat matrix of BPT Courses in Government and Private Physiotherapy collages during academic year 2020-21.

Ref:- 1. Letter No: DME/NRC(1)/10/2020-21, dated: 19-11-2020 from the Directorate of Medical Education, Bangalore.

The Karnataka Selection of candidates for admission to Nursing, Pharmacy and Physiotherapy courses Rules 2003 have been promulgated by the Government of Karnataka in exercise of the powers conferred on it by section 14(1) of the Karnataka Education Act, 1983 and section 14 of the Karnataka Educational Institutions (prohibition of capitation fee) Act, 1984. These rules have come into force from 03/07/2003, the date on which they were published in the Karnataka Gazette under Notification No.HFW 44 MPS 2003 (2), dated: 03/07/2003, the date on which they were In Government No. HFW 18 PTD 2006, dated: 19/01/2006, regulations called "admission to Post Graduate, Ayurvedha, Homeopathy, Pharmacy, Nursing and Physiotherapy courses Regulations, 2006 were issued.

The Director of Medical Education has proposed the seat Matrix of Post Graduate Courses in Government and Private Physiotherapy colleges in the state for the academic year 2020-21 vide reference (1).

In Government Order No. HFW 211 RGU 2016 dated:28/09/2016, the percentage of seat sharing in the Private Nursing and Physiotherapy colleges in the State has been published with respect to Graduate Courses for the academic year 2018-2019, in the ratio of 20:80 as 20% for the Government Quota and 80 % of Management Quota respectively. This ratio is applicable for 2020-21 academic year also.

The Managements of Private Nursing and the Physiotherapy colleges in the State Shall fill their management quota seats by following the norms as prescribed by the Government of Karnataka and the concerned Apex bodies.



Therefore, the Government of Karnataka hereby determines the intake U/s 45 (10) (b) of the Rajiv Gandhi University of Health Sciences Act 1994 and publishes the Additional Seat Matrix there under for BPT Courses conducted in Government and Private Nursing and Physiotherapy Colleges applicable for the current academic year 2020-21 as specified in the BPT Courses as in Annexure from 1-4.

As per Government order HFW 84 MMC 2019, Dated: 31.08.2019 Directorate of Medical Education shall conduct the counseling for allotment to the Government quota seats in Government Colleges/Private Nursing Schools:Colleges/Allied Health Sciences Institutions and Para Medical Colleges Seats from the academic year 2019-20.

The Tuition fee chargeable from the candidates in Government Nursing and Physiotherapy colleges and Government seats in Private Nursing the Physiotherapy colleges shall be as per the rates prescribed in the Government Orders issued from time to time.

The admission for the candidates is subject to the approval by Rajiv Gandhi University of Health Sciences, Bangalore as per the intake fixed for the academic year 2020-21 by the University.
