UGCET-2020 - Final Vacancy Round

As AICTE, New Delhi has extended the last date upto 15th January 2021 for admission to Professional Courses; Government has decided to conduct final Vacancy Round for the seats which are identified as not reported after the allotment of seats in the second extended round. The schedule for vacancy round will be published in due course on the KEA Website along with the eligibility conditions to participate in this final vacancy round.

Cancellation of seat allotted in Second Extended Round only

Hence, the provision is given to surrender / cancel, only to the candidates who have been allotted a seat in the Second Extended Round, those second extended round seat allotted candidates can cancel the seat by paying Rs.5,000/- (Five Thousand only) in the form of Demand Draft as penalty between 06-01-2021 to 08-01-2021 before 5.30 pm. (DD in favour of Executive Director, KEA, Bangalore)

Those who surrender the seat after the final vacancy round, such candidates should pay five times fees as penalty amount along with first year fees as per Government rules.

UGCET-2020- Procedure for cancellation of a Seat:

- Those candidates who have been allotted a seat in second extended round and wish to surrender / cancel the seat have to download the "Cancellation Application Form" from KEA Website http://kea.kar.nic.in and fill the same in legible form.
- 2. Scan the filled "Cancellation Application Form" in PDF format.
- 3. Obtain the demand draft for Rs.5,000/- (Five Thousand only) drawn in favour of Executive Director, KEA payable at Bangalore. (If fee not paid)
- 4. Scan the Demand Draft in PDF Format.
- 5. Send the scanned "Cancellation Application Form" and scanned "demand draft" to the following email seatcancellationkea@gmail.com from candidate's email ID.
- 6. Afterwards, send the original "Cancellation Application Form" and "Demand Draft" to KEA by registered post to the KEA postal address.
- 7. If interested candidates can cancel the seats in person in KEA, Bangalore.
