**UGCET-2023 - ENGINEERING, ARCHITECTURE, B-PHARMA, FARM SCIENCE (VETERINARY,
AGRICULTURE, HORTICULTURE) B.Sc. (Nursing) AND OTHER COURSES**

POST SEAT ALLOTMENT PROCEDURE – CHOICES BEFORE A CANDIDATE

After verifying the second seat allotment results of UGCET-2023, a candidate has the following FOUR CHOICES (only for the candidates who have been allotted a seat). If a candidate fails to exercise any of the following FOUR CHOICES within the stipulated date and time, then the seat allotted to such candidate stands cancelled automatically without any further notice in this regard and he/she will not be allowed to participate in further rounds. Candidates have to select any one choice out of the four choices, which is suitable for them. Before indicating the choice, candidates please read and understand the implication of each choice and then select the appropriate choice.

To exercise the Choices or to download the Challan or to make payment in the bank or to download the admission order, candidate need not visit KEA. For all the activities please visit KEA Website <http://kea.kar.nic.in>

If a candidate fails to exercise any one of the four choices within the stipulated date and time then the seat allotted to such candidate stands cancelled automatically without any further notice in this regard and such a candidate will not be allowed to participate in further rounds.

Candidates who have been allotted seat in UGCET -2023 second round seat allotment, can also participate in the second extended round for UGCET or in UGNEET for admission to Medical / Dental courses by selecting the appropriate CHOICE.

- If they select Choice-1, then they will not be eligible to participate in the second extended round of Engineering, Farm Science etc seat allotment and also not eligible to participate for Medical / Dental courses.
- Hence the candidates are advised to select appropriate choice to become eligible to participate in the further rounds of UGCET or in UGNEET seat allotment, if they are interested.

- In case if the candidate takes decision that he / she is not interested for any change or upgradation of a seat and willing to join the allotted seat, then only they can choose Choice-1. Further they should also know that they are not eligible to participate in the subsequent seat allotment rounds.
- Like-wise those are willing to participate in the Medical or Dental seat allotment process; they should consult their parents before selecting Choice-1 for the seat allotted them in this first round.

CHOICES

Choice 1: I am Satisfied with the UGCET-2023 allotted seat and am willing to report to the allotted college, therefore I should not be considered for further allotment of seats in any subsequent round for any college / discipline. I will pay the prescribed fees by downloading the Challan / allotted details from the KEA Website, I will download the admission order and report to the college. Immediately afterwards, I will login to my Option Entry Log-In-Id and I will report to KEA that I have joined the College.

Further the College Authority will have to login to their College Login-ID and report that the respective candidate has joined the College. If a candidate fails to report back to KEA that he / she has joined, then seat will be cancelled even though they might have physically joined.

Further any candidate who has paid the fees and obtained the Admission Order and fails to report to the College on or before the last date and time specified by KEA in the Admission Order, for such candidates no extension of time will be given and the allotment made in his / her favour shall be treated as Cancelled and he / she has no claim further on such allotment and they will not be considered for allotment of seats in the subsequent round. Such seats shall revert back to the pool and fee paid by them will be forfeited.

Implication: Not eligible to participate in the subsequent rounds.

Important: Before opting this choice candidate is advised to make sure that he / she cannot come back to Option Entry Process in UGCET-2023 / UGNEET-2023.

Choice 2: I am Satisfied with the UGCET-2023 allotted seat but wish to participate in the next round. I will pay the prescribed fees by downloading the Challan / allotted details from the KEA website for the seat confirmed or allotted in the second round. If higher options are allotted in the second extended round, then seat allotted in the second round gets cancelled automatically OR if higher order options seats are not allotted in the second extended round, then the seat allotted in the second round shall remain in candidates favour.

Implication: Eligible to participate in the second extended round keeping the seat allotted on hold. However, if a seat in the higher order options gets allotted the candidate loses his old seat. There is no choice between the earlier allotted and newly allotted seats.

NOTE: Consequential vacancies that arise during the allotment after the candidate merit / turn cannot be claimed.

Additional Instructions to Choice-2 candidates of second round

- The candidates who exercise Choice-2 should compulsorily pay the fees for the allotted seat in the second round.
- Candidates who exercise Choice-2 are participating in the second extended round by holding the seat allotted to them in the second round. If higher order options are allotted to them in the second extended round, the seat allotted during second round will automatically stand cancelled. OR if any of the Higher Order Options are not allotted in the second extended round, then the seat allotted to them in the second round will remain with the candidate.
- Higher order options means, presume that the candidate has entered 145 options, and the seat is allotted for his / her priority number 85 in the first round, then the priority number 1 to 84 are the higher order options. The lowered options i.e., from 86 to 145 get deleted automatically.
- If any of the Higher Order Options are not allotted, then the seat allotted to them in the second round will remain with the candidate.
- **Candidates can alter / delete / rearrange / modify the higher order options.**
- **Candidates are advised to enter only such options, if the seat is allotted, they have to compulsorily join the selected college in the second extended / Casual Vacancy Round seat allotment without giving any reasons /excuses.**

Choice 3: I am not satisfied with UGCET-2023 allotted seat but wish to participate in the next round by surrendering the allotted seat.

Implication: Eligible to participate in the subsequent round by rejecting the allotted seat.

Action: Candidate has to enter the options afresh; means the options saved by them for the second round will not be considered for allotment of seats for next round. Candidates are advised to enter only such options, if the seat is allotted in the second extended round, then they have to compulsorily join the selected college in the second extended / Casual Vacancy Round seat allotment without giving any reasons /excuses.

NOTE: Chances of getting the lower order options is subject to availability of seats as the other candidates next to your rank might have entered those options and seats would be allotted to them based on merit.

NOTE: Consequential vacancies that arise during the allotment after the candidate merit / turn cannot be claimed.

Additional Instructions to Choice-3 candidates

- The candidates who exercise Choice-3 need not pay the fees for the allotted seat in the second round.
- The candidates who exercise Choice-3 are NOT satisfied with the allotted seat.
- The candidates who exercise Choice-3 are participating in the second extended round by rejecting the seat allotted to them in the second round.

Choice 4: I am Not satisfied with KEA UGCET-2023 allotted seat and I have got seat elsewhere, so I am **quitting** and not to be considered for allotment of seats in any of the further rounds.

Implication: Not eligible to participate in the subsequent round for UGCET-2023 and no hold on the allotted seat and seat allotted earlier will get cancelled, can participate in UGNEET-2023 as per eligibility criteria.

Seat "NOT ALLOTTED" in second round

Candidates need not exercise any **CHOICE** entry.

Implication: Eligible to participate in the subsequent round with fresh options, the options saved by them for the second round will not be considered for allotment of seats for next round.
