The Karnataka Selection of candidates for admission to Post Basic B.sc nursing Course guidelines No. HFW 381 MSF 2018 dated:05.11.2018 have been promulgated by the Karnataka in exercise of the powers conferred on it by section 145(1) of the Karnataka Education Act.1983 and section 14 of the Karnataka Educational Institutions (prohibition of capitation fee) Act 1984. These guidelines have come into force from 05-11-2018. Applicable from the academic session 2018-19 regulating the manner of admission to the aforesaid Nursing. Post Basic B.Sc. Nursing course and the structure of fee chargeable from the students seeking admission to such courses.

- 2) The Karnataka Selection of the candidates for admission to Post Basic B.sc Nursing Course guidelines No. HFW 381 MSF 2018. Dates; 05.11.2018 have been enacted which came into force from 05.11.2018 the date on which they were published in the Karnataka Gazette under Notification the seat sharing ratio to 20:80 between the Government and the Management.
- 3) Under section Part-II (50) (2) of Karnataka Nursing Council bylaw & Government letter No: HFW 212 RGU 2016, dated:14/12/2016 and 17/05/2017 the intake of the Post Basic B.Sc.Nursing Course will have to be determined and the total number of seats under Government seat category for admission to such course both in Government and in private colleges shall be notified by Government from time to time.
- 4) Karnataka Selection of candidates for admission to Nursing Course guidelines No. HFW 381 MSF 2018, dated:05.11.2018 here by notifies particulars of the course and reservation of seats for the SCs/STs/OBCs and other special categories as applicable for the academic session 2021-22 as specified in the Annexure-1 to 8 appended to this notification.
- 5) The Fee Structure chargeable to the candidates seeking admission to Post Basic B.Sc Nursing Course under Government Quota in the Private Nursing Colleges current academic year 2021-22 shall be same as were in the previous academic year i.e.2019-20 which is as follows:

- 7) The selection of candidates for allotment to Post Basic B.Sc Nursing Course shall be strictly in conformity with the provision contained in the Karnataka Selection of candidates for admission to as per P.B.B.Sc Nursing guidelines No. HFW 381 MSF 2018 dated: 05.11.2018.
