- Ministry of AYUSH, Government of India, New Delhi has reduced the required percentile
 criteria in the AIAPGET 2020 eligibility score for admission to PGAYUSH Courses for the
 year 2020-21. Director, AYUSH department in their letter dated 19-03-2021 has informed
 to enable the online registration and to conduct the document verification process to the
 candidates who becomes eligible due to lowering of eligibility criteria.
- 2. Candidates who become eligible due to lowering of AIAPGET 2020 eligibility criteria for and who are willing to participate in the counseling process can register and pay the fees through online from 11.00 am on 22-03-2021 up to 5.30 pm on 24-03-2021 and appear for documents verification with all the original documents on 25-03-2021 from 11.00 am to 1.00 pm at KEA, Bangalore.
- Those candidates who were eligible but not registered with KEA can also register if they
 are interested and attend the document verification with all the necessary original
 documents.
- 4. Those who have already registered and verified their documents need not register once again.
- 5. Those who have already registered but not verified, can also attend the documents verification on 25-03-2021 if interested.
