Downloading of verification slip by "a" and "n" clause

Online document verification is in progress for the candidates who have claimed eligibility clauses "a" and "n". <u>Candidates claimed "a" and "n" clause need not appear for document verification</u>. The candidates who have claimed eligibility clause 'a' and 'n' in the online application form have to the verification slip from the KEA website from 05-12-2023 to 07-12-2023. However, in case if any clause 'a' or 'n' candidates are GATE qualified candidates or part time admission candidates or sponsor quota candidates, then they have to appear for document verification at KEA, Bangalore.

Document verification – (For GATE qualified candidates, Part Time course selected candidates, Sponsor quota selected candidates and those who have claimed "b, c, d" eligibility clauses in the PGCET-2023 online application)

Document verification for other eligibility clauses, GATE qualified candidates, Part Time course selected candidates, Sponsor quota selected candidates will be conducted from *05-12-2023 to 07-12-2023* through offline. Such candidates have to appear for document verification at KEA, 18<sup>th</sup> Cross, Malleswaram, Bangalore as per the following schedule. The clause wise original documents to be produced for verification is already given the e-Information Bulletin which is hosted on the KEA Website. The candidates should produce all the necessary original documents as per their eligibility clause along with one set of Xerox copies.

 Mere assignment of ranks in PGCET-2023 does not confer any right on the candidate for admission unless the candidate fulfils eligibility conditions / submits the documents / certificates.

- 2. Candidates should compulsorily produce all the required documents in ORIGINAL with one set photocopies of all the original documents.
- 3. The candidates who become eligible after verification will only be considered for entry of options to become eligible for allotment of seats.
- 4. Candidates have to be personally present as per the schedule for verifying the documents and no one can represent them.
- 5. The candidate should bring all necessary original documents with them in support of their claim / reservation made in their online application.
- 6. The academic eligibility criteria as laid down in the respective PG rules / Competitive Authority / University are applicable for admission to MBA, MCA and ME / M.Tech / M.Arch courses for the year 2023. The candidates who have got the requisite qualification are only are eligible to register for PG Admissions. Please note that SC / ST / OBC eligibility criteria are applicable to Karnataka SC / ST / OBC candidates only.
- 7. If the information submitted by the candidates in the online application form or any other document submitted by the candidate / parents are found to be false / incorrect, such candidate's seat will be cancelled at any point of time during his / her course of study and criminal proceedings will be initiated by the Government against such candidate as per Rules.
