NOTE – Online Stray Vacancy Round – PG Medical and PG Dental - 2023

In view of the Hon'ble High Court Order in WP No. 22926 / 2023, the candidates who have cancelled their clinical seats allotted under NRI / Management quota are allowed to select available pre or para clinical seats only (not for any clinical seats) in the stray vacancy round if they are interested, subject to deposition of original documents and payment of caution deposit as prescribed. Further, the candidates who have surrendered their pre/ para clinical seats are allowed for pre /para clinical seat again; and pre / para clinical selected seats would be eligible for other available clinical seats in the stray vacancy round subject to deposition of original documents and payment of caution deposit.

Date extended again for registration, verification and deposition of original documents; to pay the caution deposit and to enter the options for stray vacancy round

All other eligible seat not allotted candidates (deposited original documents, paid caution deposit) participating in the stray vacancy round can note the following:

1. New registration enabled for stray vacancy round – from 8.00 pm on 17-10-2023 to 18-10-2023 – 8.00 am (earlier not registered)
2. Verification and deposition of original documents upto 12.00 pm on 18-10-2023
3. Caution Deposit challan can be downloaded up to – 1.00 pm on 18-10-2023
4. Caution Deposit challan can be paid up to – 3.00 pm on 18-10-2023
5. Eligible candidates - Options can be exercised up to – 8.00 am on 19-10-2023
6. Publication of stray vacancy round result – after 8.00 pm on 19-10-2023
7. Submission of demand drafts at KEA, Bangalore – 20-10-2023 – deemed admission.

Steps for stray vacancy round reiterated: Deposition of originals – payment of caution deposit – option entry – submission of fees in the form of demand draft at KEA, Bangalore by deducting the caution fee paid – admission.

Caution deposit amount will be forfeited and the forfeiture of fee conditions will apply as per norms who fail to pay the fees / who fail to take the admission.
