#### (Terms & conditions)

- 1. This office does not bind itself to accept the lowest tender and reserves the right to reject any or all the tenders received without assigning any reason whatsoever. Inadequate or incomplete tenders in any respect or the prescribed conditions are not fulfilled are liable to be rejected. Canvassing in any form by the tenderer/vendor will result in rejection of their tenders.
- 2. Bidders should be registered with CPCB (Central Pollution Control Board) / SPCB (State Pollution Control Board) / PCC (Pollution control Committee).
- 3. The bidder shall enclose attested copy of Registration Certificate declaring that the Enterprise is a Registered Recycler/Re-furbisher for Disposal of E-waste. The bids shall remain valid for 60 days after the date of bid opening. If any bidder withdraws his bid before the said period shall without prejudice to any other right or remedy, be at liberty to forfeit the Bid Security absolutely.
- 4. The tenderer/Enterprise must be registered with GST Department for supply/services. Copies of such certification-mentioning registration number etc. shall be furnished along with quotation.
- 5. The tenderer/Enterprise must submit the copy of PAN Number
- 6. Bids are invited in two bid systems, (1) Technical and (2) Financial, Which shall be sealed in a separate Envelope super scribed as Technical & Financial Bid respectively.
- 7. The bidders may **inspect the items physically at KEA Office between 10 am to 5 pm on any working day up to 23-01-2023** and satisfy themselves about the items they are bidding for, as the items condition is on "As is where is basis".
- 8. The bidders may by themselves or their authorized person shall submit in person at Despatch section of KEA office "the Sealed Bids (in two different envelopes super scribed as technical & financial bids)" not later than 25/01/2023 up to 5.00 PM. No Bids will be accepted after this date & time under any circumstances.
- 9. The first envelope shall be super scribed as "Quotation for Disposal of E-Waste (Electronic, Electric & other items)" with the words "Technical Bid" in capital letters addressed to Executive Director, Karnataka Examination Authority, Malleshwaram, Bengaluru-560 012. The first envelope shall be opened on the date of opening of tender. The bidder should specifically provide full technical details of the registration with CPCB / KPCB / PCC, Certificate validity etc. and attach self-attested documents as detailed in Technical Bid Pro Forma Annexure 4. No price details shall be given in this envelope. Violation to this would result invalidation of tender. The Tender Fee & Bid Security DD shall be enclosed to the Technical bids.
- 10. The second envelope shall be super scribed as "Quotation for Disposal of E-Waste (Electronic, Electric & other items)" with the words "Financial Bid" in capital letters addressed to Executive Director, Karnataka Examination Authority,

Malleshwaram, Bengaluru-560 012. It shall contain full details of the price & Financial conditions and attach attested documents as per Annexure 5 &, Annexure 8. Any deviation from our standard conditions shall be specifically spelt out.

- 11. Any deviation of any sort e.g. Technical or financial terms and conditions shall be specifically indicated in the Technical Bid itself.
- 12. Silence or use of the word "Noted" against any of the Bid conditions shall mean bidder agrees to comply with that/those conditions of Bid.
- 13. The items shall be sold to the highest price of bidder.
- 14. Tender fee to the tune of Rs.1,000/- (Rupees One Thousand only) & An "Earnest Money Deposit (EMD)" to the tune of Rs.50,000/- (Rupees Fifty Thousand only) in the form of crossed 2 separate Demand Drafts drawn in favour of Executive Director, Karnataka Examination Authority, Bengaluru shall be submitted with Technical Bids.
- 15. The Earnest Money Deposit of the successful bidder shall be adjusted in the bid forthwith. The EMD of unsuccessful bidders shall be returned within one month of the auction date, without any interest.
- 16. Once the items disposed to the successful bidder shall not be taken back by office of KEA.
- 17. This bid will be processed on an "As is where is Basis". The contractor shall indemnify this office against any liability for compensation due to injury to his own workmen/engineer or to other persons inside the office premises while executing the contract and for any damage to the property.

## 19. Opening of Bids:

- a) The purchaser will open the Technical bids as per scheduled time, date and venue in the presence of the bidders' representatives who choose to attend.
- b) The bidders' representatives who will be present shall sign in the designated register evidencing their attendance, In the event of the specific bid opening being declared a holiday for the purchaser, the bid shall be opened at the same time and location on the next working day.
- c) The bidders' names, bid withdrawals, presence of bid security and such other details as the Purchaser at his discretion may consider appropriate will be announced at the bid opening.

# d) The Enterprises who have submitted the bids and whose offers are found technically suitable shall be informed the opening date of the second envelop i.e. "Financial Bid (Price Bid)".

- 20. The successful bidder will be required to deposit the total bid/quoted (EMD amount will be adjusted with the quoted value) amount in Lump Sum by means of Demand Draft / Pay Order / Banker's Cheque in favour of Executive Director, Karnataka Examination Authority, Bengaluru, within 05 working days from the date of award of contract and the items will be lifted within 5 days of the receipt of confirmed work order by the Bidder. If the successful bidder fails to deposit the quoted amount within stipulated date, the EMD of the H1 Enterprise will be forfeited. The lifting of materials will be made by contractor on any working day as specified between 10 AM to 5 PM. The contractor will have to inform at least one day in advance of the intended date of lifting of the materials. The contractor will be required to bring his own vehicle for lifting the materials and will employ his own labour, bags, and other items as required for packing and lifting of the obsolete materials will be allowed from the designated places only and after issuance of necessary security/gate pass.
- 21. Vendor should ensure that all e-waste is disposed / reused as per latest government guidelines. Vendor should submit disclaimer related to this with their proposal.
- 22. Each page of the Tender documents must be stamped and signed by the person or persons submitting the Tender in token of his/their having acquainted himself/themselves and accepted the entire tender documents including various conditions of contract. ## 4. Other conditions for submission of bids
