NOTE- Final Chance to enter the RD Number / claims in the application for CET-2024
(from 11.00 am on **09-05-2024 to 15-05-2024** upto 11.59 pm)

1. KEA has received requests from candidates to provide opportunity to correct the RD Numbers / to claim the reservation's in the CET-2024 application. In view of this KEA is providing the final opportunity to candidates to correct RD numbers and correct the claims in the CET-2024 application from 11.00 am on **09-05-2024 to 15-05-2024** upto 11.59 pm. After this prescribed period, neither correcting RD numbers /editing the CET-2024 application details nor claiming of reservation will be permitted under any circumstances and also requests to correct the application will not be entertained. Hence candidates are advised to verify the details / claims made in the CET-2024 application and correct the details if required; with regard to Eligibility Clause (except 'c' and 'd'), Reserved Category, Annual Income, Hyderabad Karnataka Reservation 371 (j), Study in Kannada medium, Study in Rural areas, Special Category, etc.
2. *Information with regard to caste, income and 371(j), NCLC and other RD related certificates will be verified through Web-service based on the Caste / Caste Income Certificate RD Number and 371(j) RD number entered by the candidate in the online application form. Candidate has to enter the correct RD number carefully in the online application.*
3. *SC, ST and Cat-1 candidates should obtain income certificate and enter the RD number of the income certificate carefully to avail the benefit of fee exemption.*
4. *General merit candidates who claim seat in rural category should also obtain **Non Creamy Layer Certificate** (NCLC) issued from the concerned Tahasildar and enter the RD Number without fail.*
5. *General Merit candidates if their annual income is below Rs.8.00 Lakhs, they have to obtain income certificate from the concerned Tahasildar and enter the RD number of the income certificate carefully, to claim Supernumerary Quota (SNQ).*

6. Student is claiming Hyderabad Karnataka Reservation 371 (j) (Kalayana Karnataka) then he / she should mention as YES against the Hyderabad Karnataka Reservation and enter the correct RD Number. Only such candidates will become eligible to claim Hyderabad Karnataka Reservation.
7. Further, students claiming seats under special categories such as NCC, Sports, Defence, Ex-Defence, CAPF, CRPF, Ex-CAPF, Scouts & Guides, Physically Disabled etc., should have correctly mentioned reservation / claims in their application form and the corresponding certificates needs to be uploaded in case if they have not uploaded the certificates.
8. *The student entries pertaining to school study, Kannada medium, caste, income etc will be verified through SATS / Revenue department web service. There will be no physical verification.*
9. Minority reservations can also be claimed for Medical and Dental courses.

Methods to be followed to correct the details / change the entries / claims

1. Select the appropriate link in the KEA Website and login by using log-in credentials.
2. Then select the "Edit required for", and then select the required field to edit (eligibility clause Update, RD details update, Course Update, Upload Documents, Reservation Claims, Special Category claims).
3. Before selecting the 'Declare Button', confirm that all the entries / claims are correct. You cannot be allowed to edit the application again if the 'Declare Button' is selected.
4. After completion of process of editing / changes in the application form, select the 'Final Submission' button, failing which the data entered by you earlier will be restored and will be the basis for further processing.
5. Then, take the print out of edited application form and preserve it safely. Preserve at-least 5 copies of print out of application.
